

ADMINISTRATIVE LAW JUDGE’S DECISION AND SUPPORTING BRIEF**


The Respondent, Three D, LLC d/b/a Triple Play Sports Bar and Grille (“Triple Play”), hereby moves for an extension of time of twenty eight (28) days, up to and including February 28, 2011, in which to file exceptions to the decision of the administrative law judge and a brief in support of such exceptions. In support of this Motion, Triple Play states that, due to the length and complexity of the Administrative Law Judge’s Decision, additional time is necessary in order for counsel to thoroughly analyze the decision and prepare appropriate exceptions thereto. Furthermore, counsel for Triple Play is scheduled to assist with the preparation and trial of a civil action, entitled One Research Parkway, LLC v. Insurance and Risk Management Associates, LLC, Docket No. CV 09-5004981 S, which is scheduled to begin trial on February 9, 2012 in the Connecticut Superior Court for the Judicial District of Meriden, and a civil rights action, captioned Musco Propane, LLC v. Town of Wolcott, et al., Docket No. 3:10

CV-01400-JCH, which is scheduled to be trial ready on February 15, 2012 in the United States District Court for the District of Connecticut at Bridgeport. Accordingly, due to counsel's present trial schedule, additional time is needed for the preparation of exceptions to the Administrative Law Judge's decision and a brief in support thereof.

WHEREFORE, Triple Play respectfully requests that its motion for extension of time be granted.





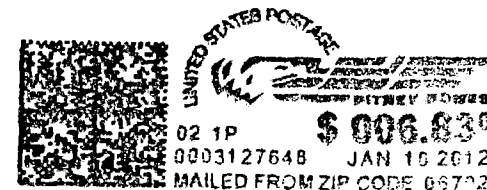
