**WEYERHAEUSER COMPANY’S MOTION FOR A TWO-WEEK EXTENSION  
OF TIME FOR THE PARTIES TO FILE ANSWERING BRIEFS**

Pursuant to Section 102.46 of the Board’s Rules and Regulations, Respondent Weyerhaeuser Company (“Weyerhaeuser” or “Company”), hereby moves for a two-week extension of time for the parties to file their answering briefs to the Exceptions to the Administrative Law Judge’s decision. In support thereof, Weyerhaeuser states the following:

1. The Administrative Law Judge decision in this matter was issued on January 30, 2012.
2. On February 27, 2012, both Weyerhaeuser and Counsel for the Acting General Counsel filed Exceptions to the Administrative Law Judge’s decision, and briefs in support of such Exceptions.
3. Pursuant to Section 102.46(d)(1), answering briefs for each party are due within 14 days of February 27, or on March 12, 2012.
4. Weyerhaeuser has recently retained additional counsel in this matter – Charles I. Cohen, Philip A. Miscimarra, and Ross H. Friedman of Morgan, Lewis & Bockius. In order for new counsel to become acquainted with the facts of the case,

Respondent respectfully requests a two-week extension of time – from March 12 to March 26, 2012 – for the parties to file their answering briefs.

4. This is the first extension request, and Weyerhaeuser does not anticipate requiring any further extensions.

5. Counsel for the Acting General Counsel does not oppose the two-week extension

For all the foregoing reasons, Weyerhaeuser respectfully requests that its motion be granted, and that the time in which to file answering briefs be extended from March 12, 2012 until March 26, 2012.
