**Joint Request to Extend Time for Filing Exceptions**

Dear Mr. Heltzer:

Exceptions to the Administrative Law Judges' Decision in the above captioned matter are due Friday, December 21, 2012. The Parties have successfully concluded collective bargaining negotiations and also negotiated a settlement of the outstanding unfair labor practice allegations.

By letter of December 19, 2012, the Charging Party has requested withdrawal of the unfair labor practice charges based upon the above settlement. It is not clear if the Board will act on the Charging Party's request prior to the date for filing Exceptions.

Pursuant to Section 102.46 of the Board's Rules and Regulations Counsel for the Respondent and Charging Party jointly request an extension of time for filing exceptions. This requested extension will be until the Board rules on the Charging Party's withdrawal request plus one week.


