Dear Executive Secretary Shinnars:

I am the lead attorney for the Employer in the above-captioned case. I previously requested, and your office granted, adjournment of the Employer's time to file its exceptions and supporting brief from August 28, 2013 through September 12, 2013. Due to unexpected work commitments as well as an unexpected medical appointment tomorrow, I am requesting a further adjournment of the above-referenced filing date until September 17, 2013. As noted, this is the second request for an adjournment in connection with exceptions to the ALJ's decision.


Among the work commitments referenced above is a reply brief in *Phillips 66, Bayway Refinery v. International Brotherhood of Teamsters, Local 877*, which is filed in the United States District Court for the District of New Jersey, Case No. 2:13 Civ. 4910. I had previously understood that I would have until September 23 to complete this document, which involves some rather esoteric issues. However, today I learned that the reply brief will be due this week, and I cannot advance both the exceptions brief in this case and that reply brief to conclusion simultaneously given other commitments. Accordingly, I respectfully request a 5-day adjournment of the filing date herein for exceptions and the supporting brief until September 17.

Counsel for the General Counsel and Union counsel have not yet advised of their respective positions to the instant adjournment request. In fairness, I only solicited their position between 2:30 pm and 3:00 pm this afternoon. I trust that they will advise your office directly as to their respective positions. In Ms. Elrashedy's case, I understand from an automatic email reply that she is not at work today but will be returning to work tomorrow.
