GENERAL COUNSEL'S ANSWERING BRIEF TO RESPONDENT'S
EXCEPTIONS UNDER BOARD RULE 102.46(h)**

Respondent's Reply Brief to Counsel for the Acting General Counsel's Answering Brief to Respondent's Exceptions to the Decision, filed on September 20, 2013, violates Board Rule 102.46(h) as it exceeds the page limit set forth in the rule. Board Rule 102.46(h) states, in pertinent part:

Any reply brief filed pursuant to this subsection shall be limited to matters raised in the brief to which it is replying, and shall not exceed 10 pages. No extensions of time shall be granted for the filing of reply briefs, nor shall permission be granted to exceed the 10 page length limit.

Respondent previously violated the page limit set forth in Board Rule 102.46(j) by filing a 99 page Brief in Support of its Exceptions 49 pages *over* the limit set forth in the rule. Because Respondent has shown its repeated disregard for the Boards Rules and Regulations, Counsel for the Acting General Counsel objects to the filing of Respondent's September 20, 2013, Reply Brief.
