**JOINT MOTION FOR EXTENSION OF TIME TO FILE ANSWERING BRIEFS TO
EXCEPTIONS**

Pursuant to Section 102.46 of the National Labor Relations Board Rules and Regulations, the parties jointly request an extension of time to file their answering briefs to exceptions to the Decision of the Administrative Law Judge from November 1, 2013, until November 18, 2013, for the following reasons:

1. The parties have been and are in the process of analyzing exceptions filed with the Board that address the ALJ's Decision regarding a 570-page complaint and more than 1,600 requests for information, and will require an extension of time to prepare their responses.
2. The answering briefs are currently due November 1, 2013 pursuant to the Board previously granting an extension of time on October 17, 2013.
3. The government was shutdown for the first sixteen days of October 2013, which prevented Counsel for the Acting General Counsel from drafting his Answering Brief.

4. The parties agree that the current request is for good cause and will not prejudice any party.
