

This firm represents Pioneer Transportation Corp. and Pioneer School Bus Rental Corp. (collectively, "Pioneer"). In accordance with the agreement reached between Pioneer and charging party, Local 1181, ATU, and with an email dated today from Board Agent Annie Hsu indicating that Region 29 agrees with Pioneer's backpay calculations in full satisfaction of the backpay component of Judge Green's decision, Pioneer hereby withdraws the exceptions filed on its behalf in these matters. Pioneer will also withdraw its appeal of the 10(j) injunction (Second Circuit Docket No., 13-3339), as well as its participation in case no. 13-1221 currently pending before the D.C. Circuit.
