PETITION FOR AN EXTENSION OF TIME TO FILE

TO THE EXECUTIVE SECRETARY:

COMES NOW, Hospital Español Auxilio Mutuo de Puerto Rico, represented by the undersigned attorney, in order to RESPECTFULLY REQUEST FURTHER TIME TO FILE EMPLOYER'S EXCEPTIONS:

1. Pursuant to a Stipulated Election Agreement executed by the parties and issued and approved by the Regional Director for Region 24 on March 6, 2012, an election by secret ballot was conducted on March 23, 2012 between Unidad Laboral de Enfermeras(os) y Empleados de la Salud, Petitioner, and two Intervenors, Comité Unionados de Enfermeros Prácticos del Auxilio Mutuo and Asociación Internacional de Maquinistas y Trabajadores Aeroespaciales. Thereafter, the Petitioner filed timely objections to conduct affecting the results of the election.

2. In conformity with Section 102.68 of the Board's Rules and Regulations and pursuant to the Stipulated Election Agreement, Acting Regional Director for Region 24 caused an investigation to be made of the objections and recommended a hearing be held to resolve the issues raised by Petitioner's Objections.

3. Following the Board's Rules and Regulations, Sections 102.111-102.114, concerning the Service and Filing of Papers, exceptions to the Report and Recommendation on Objections and Notice of Hearing, must be received by the Executive Secretary of the Board, by May 4, 2012.

4. Although we have been working in the preparation of said exceptions, we anticipate that it cannot be diligently prepared and filed on the set date because of the nature and extension of the Petitioner's objections.

5. In support of our petition it is relevant to mention that of the seventeen objections filed by the Petitioner, nine of the issues raised by Petitioner's Objections are to be resolved in a hearing. Said hearing was scheduled to be conducted on May 4, 2012, but has been rescheduled for May 7, 2012.

6. In view of the aforementioned we understand reasonable to request further time to file our exceptions; specifically until May 18, 2012.

WHEREFORE, we respectfully request that an Extension of time to file exceptions until May 18, 2012 be granted to this party.


