
**REQUEST FOR EXTENSION OF TIME TO FILE ANSWERING BRIEF**

Counsel for the Acting General Counsel respectfully requests an extension of time, from January 4 to January 25, 2013, to file an answering brief in response to Respondent's cross-exceptions to the Administrative Law Judge's decision in the above-captioned matter. The request for postponement is due to the fact that in addition to numerous case handling responsibilities Counsel for the Acting General Counsel is in the process of being transferred from Subregion 34 to Region 3.
