25 Charging Party requests that the Board modify its Decision and Order to conform to the
26 Board's recent decision in *Bud Antle, Inc.*, 359 NLRB No. 140 (2013). In particular, the
27 Charging Party requests that the Board apply footnote 2 which requires that the Notice be mailed
28 "to all current and former employees employed by the Respondent at any time from the onset of
the unfair labor practices until the date the notices are mailed." Posting is not a sufficient remedy
here where these companies are engaged in the construction industry and have work from time to
time. The current employees are just remotely connected to these unfair labor practices. The
Board should apply *Bud Antle, Inc.* in this case.

Additionally, Respondents should be required to mail the Board's decision along with a
notice. The mere receipt of the notice only without the Board's decision is not a sufficient

1 explanation of what occurred. The employees should be entitled to read the Board's decision as
2 part of any mailing.

3 In addition the Board's notice should identify the website where the Board's decision is
4 available. This will enable employees to read it if they wish.
