We represent Petitioner Pacific Northwest Regional Council of Carpenters, Local 2403 in the above-referenced matter.


All parties were served with the Decision and Order on October 17, 2014. Petitioner intends to file a Request for Review, which is currently due to be filed and served on October 31, 2014.
