**PETITIONER'S MOTION FOR VOLUNTARY DISMISSAL OF ITS PETITION FOR
INJUNCTION UNDER SECTION 10(j) OF
THE NATIONAL LABOR RELATIONS ACT, AS AMENDED**

Pursuant to Rule 41(a)(2) of the Federal Rules of Civil Procedure, Counsel for the Petitioner, Allen Binstock, the Regional Director for Region 8 of the National Labor Relations Board, respectfully moves for voluntary dismissal of this case for the following reasons.

On January 15, 2015, Administrative Law Judge Arthur Amchan issued his decision on the underlying unfair labor practice case, dismissing the complaint. In light of the Administrative Law Judge's decision, Counsel for the Petitioner moves to voluntarily dismiss its request for injunctive relief without prejudice.

Accordingly, the Petitioner respectfully requests this Court to grant its motion for voluntarily dismissal of its petition for injunction without prejudice.
