18 The Charging Party hereby joins in the General Counsel's Motion for Summary
19 Judgment.

20 The Charging Party suggests additional appropriate remedies:

- 21 (1) The Board's Notice should have a reference to the Board's App. which is available so
22 that employees can learn their rights;
- 23 (2) The Board's Notice and any Order or Decision should be mailed to the employees.
24 The Notice posting is inadequate unless the employees have access to and can read the
25 Board's decision;
- 26 (3) The Notice should be amended to require that whatever company official signs the
27 Notice print his or her name. Increasingly management representatives are scrolling
28 their names in ways that are illegible. It would not be a burden on any Respondent
and it would clarify Notices to have their name printed on the Notice. This will avoid
