

(1) the order of the respondent National Labor Relations Board (NLRB) denying petitioner's motion for reconsideration/reopening the record entered the twentieth day of March, 2015 in cases 5-CA-31828 and 5-CA-33125 (formerly 2-CA-36129), found at 362 NLRB No. 38, as corrected on the twenty-seventh day of March, 2015, found at 362 NLRB No. 38, and further corrected on the second day of April, 2015, found at 362 NLRB No. 38; and

(2) the decision and order that the NLRB entered the fifteenth day of September, 2014 in cases 5–CA–31828 and 5–CA–33125 (formerly 2–CA–36129), found at 361 NLRB No. 47.


