**COUNSEL FOR THE GENERAL COUNSEL'S MOTION TO AFFIRM COMPLIANCE

On April 14, 2015, Administrative Law Judge Geoffrey Carter severed the above-captioned matter from a Consolidated Complaint in Cases 13-CA-110452 and 13-CA-114222, and approved a settlement agreement between the parties that resolved the issue in Case 13-CA-110452. On the record, ALJ Carter remanded Case 13-CA-110452 to the Region to monitor for compliance and requested that the Counsel for General Counsel file a motion to close the case upon completion of compliance.

On July 8, 2015, Region 13 issued its closing letter to all parties to Case 13-CA-110452, confirming that Respondent had achieved compliance in the matter.

Since Respondent has complied with the terms of the settlement agreement, Counsel for the General Counsel moves to affirm compliance with the settlement agreement and moves to have the record closed.


