At our meeting last week, planned rates of pay for the Dayton Chapter of Reserve Teachers, in short term assignments, were announced by Parallel Staffing. Furthermore, the rate of pay for longer term assignments, in excess of 60 days, was not known. Currently, long term reserve teachers transition to the Dayton Education Association pay scale on

the 61st day. We believe that in order to continue to effectively cover classroom assignments, after January 1, 2015, this pay rate and other related benefits must continue. Additionally, there are several other topics and issues that need to be addressed.
