

ORDER

On August 27, 2015, the Board issued an Order in *Lin Telephone Corporation*, 362 NLRB No. 197, in which it granted the Charging Party's request for Special Permission to appeal an order approving a unilateral non-board settlement (consent order) of the above-referenced matter and granting the Charging Party's appeal on the merits. Accordingly, the Board ordered that the agreement/consent order be set aside and that this matter be remanded to me for further action consistent with the Board's Order.

The parties are hereby directed to submit statements of position as to the further processing of this matter and the issues to be considered therein. Such statements of position should be filed and served no later than the close of business on Tuesday, September 29, 2015.¹
