1. The Administrative Law Judge (ALJ) erred by his failure to find that Mike Watson (Watson) was an agent of Respondent. ALJD 6:30-31.
2. The ALJ erred by his failure to find that Respondent, through Watson, reported an argument between he and Joe Moore (Moore) with the intent to have Moore suspended and terminated, and by this conduct, attempted to cause, and caused, Fiat Chrysler Automobiles Group to suspend and discharge Moore. ALJD 7:26-28.
