Reason for Extension of Time	<p>The original hearing produced 1740 pages of transcript and over 80 exhibits. The briefing schedule crosses over both the Christmas and New Year's holidays. Since the close of the hearing, Respondent has filed fifteen objections to an election that occurred on December 4 and 5, 2015. On December 16, 2015, the Region scheduled a hearing for January 5, 2016 to resolve the issues raised by the objections. This hearing could last several days, and prior to that Respondent and its counsel will need to prepare. Due to the length of the original hearing and the volume of transcripts, the occurrence of two holidays during the briefing period, as well as the fact that an election objection hearing involving the same Region, Respondent and Respondent's counsel has been scheduled during the briefing period, Respondent requests additional time to adequately prepare a post hearing brief addressing the many issues for decision by the Administrative Law Judge. This is Respondent's first request for an extension of time, and it will not unduly delay the proceedings. Counsel for Respondent reached out to Judith E. Dávila, Counsel for the General Counsel, on Friday, December 18 and again on Tuesday, December 22, but she has not responded. For the foregoing reasons, Respondent respectfully requests that the due date for filing post-hearing briefs be extended to Tuesday, February 16, 2016, with Respondent's summary judgment reply due March 1.</p>
