PARTIES' FIRST STATUS REPORT

Pursuant to the Court's October 30, 2015 Order directing the parties to file status reports every 90 days, the National Labor Relations Board ("the Board"), and Latino Express, Inc. ("the Company"), by their respective counsel, respectfully submit this first status report.

1. The parties have reached a consolidated settlement agreement resolving several matters. The Company is in the process of complying with the terms of the settlement agreement that pertain to the Board Order in this case.

2. To date, the Company has satisfactorily: posted the required remedial notice, which must remain posted until March 4, 2016; read the remedial notice in English and Spanish to its employees; reinstated the two unlawfully discharged employees; provided a certification that it expunged from their files the matters the

Board ordered to be expunged; and completed reports for the Social Security Administration for the two employees.

3. To date, the Company has not yet satisfactorily provided: documentation that it has paid the required backpay, with interest and excess tax, to the two employees; and copies of written notifications to the two employees that it expunged from their files the matters the Board ordered to be expunged.

4. Counsel for the Company L. Steven Platt has authorized counsel for the Board to file this joint status report.
