Counsel for the General Counsel's Answering Brief to Respondent's Exceptions to the Administrative Law Judge's Decision in the above-captioned cases is currently due on February 26, 2016. Pursuant to Section 102.46 of the NLRB Rules and Regulations, Counsel for the General Counsel hereby requests an extension of time until March 21, 2016 to file the answering brief.

Additional time is being requested because Counsel for the General Counsel learned, on February 22, 2016, that a non-board settlement has been reached, in principle, as to one of the charging parties, Juan Placencia. This non-board settlement is expected to fully remedy the violations found by ALJ Laws, and it is anticipated that a request to withdraw these allegations will follow. The requested extension of time will permit the non-board settlement to be completed, executed, and presented in support of a request to sever and withdraw the allegations of Case 21-CA-140545.

All parties have been informed of this request, but we have not heard back yet from Charging Party Jaime Romero or the Petitioner Union. Respondent's counsel and Charging Party Juan Placencia's counsel do not oppose this request. Thank you for your consideration.
