PETITION FOR REVIEW

Pursuant to Rule 15(a) of the Federal Rules of Appellate Procedure, RGIS, LLC (herein “Petitioner”), hereby petitions the United States Court of Appeals for the Fifth Circuit to review and set aside a Decision and Order of the National Labor Relations Board (“Board”) in the matter styled *RGIS, LLC and Clara Harris*, Case No. 28-CA-136313, reported at 363 NLRB No. 132, dated February 23, 2016. See Exhibit A. This Court has jurisdiction in this matter pursuant to Section 10(f) of the National Labor Relations Act because the NLRB’s Decision and Order is a final order. 29 U.S.C. § 160(f). Petitioner is a party aggrieved by this Decision and Order, and Petitioner transacts business within this judicial circuit as defined in 28 U.S.C. § 41. The Board’s Decision and Order is not supported by substantial evidence and is contrary to law.

WHEREFORE, Petitioner respectfully prays that this Court review and set aside the Board's Decision and Order and that Petitioner receive any further relief to which it may be entitled.
