TO THE DECISION OF THE ADMINISTRATIVE LAW JUDGE**


Pursuant to Section 102.46 of the Board's Rules and Regulations, Series 8, as amended, the undersigned Counsel for the General Counsel respectfully files the following Exceptions to the Decision of the Honorable Arthur Amchan, Deputy Chief Administrative Law Judge in the above-captioned matter in the following particular:¹

1. (ALJD pp. 6-7) To the failure to find that Oberthur Technologies of America, herein called Respondent, violated Section 8(a)(5) and (1) of the Act by refusing to bargain with the Union prior to imposing discretionary discharges on employees Albert Anderson, Lawrence Bennethum, Dan Clay, and Harvey Werstler.

2. (ALJD p. 9) To the failure to order Respondent to reinstate and award backpay and search for work expenses to employees Albert Anderson, Lawrence Bennethum, Dan Clay, and Harvey Werstler.
