GENERAL COUNSEL'S MOTION TO EXTEND

Comes now Counsel for the General Counsel, and respectfully submits this Motion to Extend the Deadline for the Filing of Exceptions and Brief in Support of Exceptions pursuant to Section 102.46 of the Rules and Regulations of the National Labor Relations Board. In support of this motion, Counsel for the General Counsel offers the following:

On August 31, 2015, the Region issued a complaint in the above-captioned case. On January 28, 2016, an administrative hearing was held before Administrative Law Judge David Goldman regarding the instant case. On April 5, 2016, the parties filed post-hearing briefs. On July 13, 2016, Judge Goldman issued his decision dismissing the complaint regarding the instant case in its entirety. The deadline for the filing of exceptions and briefs in support of exceptions is currently August 10, 2016. Counsel for the General Counsel requests a five-day extension of that deadline to August 15, 2016.

The Counsel for the General Counsel has experienced an emergency within his family. The extension of the deadline for the filing of exceptions and briefs in support of exceptions will give the Counsel for the General Counsel the opportunity to appropriately prepare timely and well-drafted exceptions and brief in support of said exceptions in the instant case.
