NOTICE OF INTENT TO AMEND CONSOLIDATED COMPLAINT

Pursuant to Section 102.17 of the Rules and Regulations of the National Labor Relations Board, Series 8, as amended, at the outset of the hearing in the above-captioned case, Counsel for the General Counsel will amend the Consolidated Complaint (the Complaint) that issued on August 31, 2016, as follows:

Remove the reference to Case 28-CA-166571 from the introductory paragraph of the Complaint.

Remove paragraph 5(e), 5(k) and 5(n) from the Complaint, and replace paragraph 5(l) with new paragraph 5(l) reading:

5. (l) The subjects set forth in paragraph 5(j) relates to wages, hours, and other terms and conditions of employment of the Unit and are mandatory subjects for the purposes of collective bargaining.

Further, the Counsel for the General Counsel withdraws charge 28-CA-166571 and corrects the caption to read:
