1. GC Exhibit 1(c) – Compliance Specification for Case 26-CA-023497 – GC Exhibit 1(c) contains four attachments labeled as Exhibits 1 through 4. The Exhibit 3 attached to GC Exhibit 1(c) concerns the backpay calculations for discriminatee Renal Dotson. The trial record exhibits provided do not contain pages 2 and 4 of the calculations. A copy of the complete 5 page Exhibit 3 attachment to GC Exhibit 1(c) is attached to this motion.
2. GC Exhibit 1(c) – Compliance Specification for Case 26-CA-023497 – GC Exhibit 1(c) contains four attachments labeled as Exhibits 1 through 4. The Exhibit 4 attached to GC Exhibit 1(c) concerns the backpay calculations for discriminatee Jerry Smith. At the hearing, the General Counsel amended the Compliance Specification for 26-CA-023497 through Exhibit 4 – Revised which presented the corrected backpay calculations for Smith. The Exhibit 4 – Revised, which is part of the exhibits, should be attached to GC Exhibit 1(c) but was mistakenly attached to GC Exhibit 4.
3. GC Exhibit 1(h) – Compliance Specification for Case 26-CA-023675 – GC Exhibit 1(h) contains four attachments labeled as Exhibits 1 through 4. The Exhibit 2 attached to GC Exhibit 1(h) concerns the backpay calculations for discriminatee Glorina Kurtycz. At the hearing, the General Counsel amended the Compliance Specification for 26-CA-023675 through Exhibit 2 – Revised which

presented the corrected backpay calculations for Kurtycz. The Exhibit 2 – Revised, which is part of the exhibits, should be attached to GC Exhibit 1(h) but was mistakenly attached to GC Exhibit 2.

The General Counsel sought Respondent’s position concerning this motion and, on November 8, 2016, by email, counsel for Respondent informed the General Counsel that it had no opposition to this motion.

WHEREFORE, for the foregoing reasons, Counsel for the General Counsel respectfully requests that the trial record exhibits be corrected as set forth in this motion.
