**GENERAL COUNSEL'S NOTICE OF INTENT

Pursuant to Section 102.17 of the Rules and Regulations of the National Labor Relations Board, Series 8, as amended, at the outset of the hearing in the above-captioned cases, Counsel for the General Counsel will move to amend the Consolidated Complaint and Notice of Hearing, which issued on November 9, 2016, as follows:

1. By replacing the present paragraph 4(b) with the following new paragraph 4(b):

4. (b) At all material times, the following individuals held the positions set forth opposite their respective names and have been agents of Respondent within the meaning of Section 2(13) of the Act:

2. By adding the following new paragraph 6(d):

6. (d) About April 27, 2016, Respondent issued written discipline to its employee Ana Garcia.

3. By inserting the words “and 6(d)” after the words “paragraph 6(a)” in paragraph 6(b).
4. By inserting the words “and 6(d)” after the words “paragraph 6(a)” in paragraph 6(c).
5. By inserting the words “and 6(d)” after the words “paragraphs 5(b) through 5(j), 5(l) through 5(o), and 6(a) and 6(b)” in paragraph 7.
6. By inserting the words “and 6(d)” after the words “paragraphs 6(a) and 6(c)” in paragraph 8.
