PETITION FOR REVIEW



Tramont Manufacturing, LLC (Tramont), the Petitioner herein, hereby petitions the Court for review of the Order Vacating, and Decision and Order on Remand of the National Labor Relations Board (Board), the Respondent herein, in NLRB Case No. 18-CA-155608, finding that the Petitioner violated Sections 8(a)(1) and (5) of the National Labor Relations Act (29 U.S.C. §§ 158(a)(1), (5)). The Board's Order Vacating, and Decision and Order on Remand was entered on April 7, 2017 and is reported at 365 NLRB No. 59. A copy is attached hereto as Exhibit A. This petition is filed pursuant to Section 10(f) of the National Labor Relations Act (29 U.S.C. § 160(f)), Rule 15 of the Federal Rules of Appellate Procedure, and Rule 15 of the Circuit Rules of the United States Court of Appeals for the District of Columbia Circuit. A Service List is attached as Exhibit B, and a Corporate Disclosure Statement is attached as Exhibit C.

WHEREFORE, the Petitioner hereby requests that the Court grant the petition for review and set aside the Board's Order Vacating, and Decision and Order on Remand.


