COUNSEL FOR THE GENERAL COUNSEL'S REQUEST FOR AN EXTENSION OF TIME  
TO FILE AN ANSWERING BRIEF AND TO FILE CROSS-EXCEPTIONS AND A BRIEF IN  
SUPPORT OF CROSS-EXCEPTIONS

Pursuant to Section 102.2(c) of the Board's Rules and Regulations, and for the reasons set forth below, Counsel for the General Counsel (General Counsel) respectfully requests an extension of time to file an answering brief to Respondent's exceptions to Administrative Law Judge (ALJ) Jeffrey D. Wedekind's decision in the above-captioned cases. Pursuant to Section 102.2(c) of the Board's Rules and Regulations, General Counsel also requests an extension of time to file cross-exceptions to ALJ Wedekind's decision and a brief in support of those cross-exceptions.

Pursuant to Section 102.46(b)(1), General Counsel's answering brief to Respondent's exceptions is currently due no later than June 19, 2017. Pursuant to Section 102.46(c), any cross-exceptions and brief in support are also currently due no later than June 19, 2017.

However, General Counsel has prior commitments which will take him away from the office for

several days, leaving insufficient time to prepare an answering brief, cross-exceptions and a brief in support of cross-exceptions by June 19, 2017.

In light of the foregoing, General Counsel respectfully requests an extension of time to file an answering brief to Respondent's exceptions, up to and including June 30, 2017. General Counsel also respectfully requests an extension of time to file cross-exceptions and a brief in support, up to and including June 30, 2017. This is General Counsel's first request for an extension of time. General Counsel has also contacted counsels for Respondent and the Charging Party to solicit their positions with respect to this request. Neither party objects to this request.
