**ORDER (1) GRANTING UNOPPOSED MOTION TO REMAND CASES TO THE
REGIONAL DIRECTOR AND (2) REMANDING CASES TO REGIONAL DIRECTOR**

The record in this proceeding closed on December 1, 2017. Today, Counsel for the General Counsel filed a Motion for Remand of Cases to Regional Director to Approve Withdrawal of Charges and Dismiss Consolidated Complaint Based on Non-Board Settlement Agreement (Motion to Remand), pursuant to Section 102.24 of the Board's Rules and Regulations.

In support of the Motion to Remand, Counsel for the General Counsel states as follows:

- Charging Party International Union of Operating Engineers Local Union 501, AFL-CIO (Charging Party) on January 23, 2018, submitted a request to the Regional Director for Region 28 seeking to withdraw the charges underlying this proceeding;
- Charging Party's request was based upon a non-Board settlement agreement entered into by Charging Party and Respondent IGT d/b/a International Game Technology (Respondent); and
- Neither Respondent nor Charging Party opposes the Motion to Remand.

Based on the foregoing, I find that it would effectuate the policies of the Act to grant the unopposed Motion to Remand and remand this action to the Regional Director for Region 28.

Accordingly, it is **ORDERED** that the General Counsel's unopposed Motion to Remand is **GRANTED**, and

IT IS FURTHER ORDERED that this case is **REMANDED** to the Regional Director for Region 28 for further handling consistent with this Order.
