MOTION TO REMAND PROCEEDINGS TO THE REGIONAL DIRECTOR

Jamie Rucker, Counsel for the General Counsel of the National Labor Relations Board, files this Motion to Remand the above-captioned case to the Regional Director of Region 2 for the following reasons.

1. On May 11, 2018, Outten & Golden, LLP, counsel for the Charging Parties in this matter, submitted a Withdrawal Request, seeking to withdraw the charge in this matter. A copy of that request, together with its accompanying affidavit of service, is attached hereto as Exhibit 1.

2. On May 21, 2018, counsel for the Charging Parties confirmed to the undersigned that the Withdrawal Request was made pursuant to a settlement between the Charging Parties and Respondents.

3. Also on May 21, 2018, the Supreme Court issued its decision in *Epic Systems Corp. v. Lewis*, No. 16-285 (May 21, 2018).

4. Based on the foregoing facts, counsel for the General Counsel will recommend approval of the Withdrawal Request.

WHEREFORE, counsel for the General Counsel respectfully requests that its Motion to Remand Proceedings to the Regional

Director be granted so the Regional Director may facilitate disposition of these matters, based upon the parties' settlement identified above.


