This Court having on March 3, 2017, in No. 16-73079, entered its judgment enforcing in full the Order of the National Relations Board in Board Case Nos. 21-CA-120477 and 21-CA-121946, the Board on January 4, 2018, issued its Supplemental Decision and Order and having thereafter applied to this Court for summary entry of a judgment:

IT IS HEREBY ORDERED AND ADJUDGED by the Court that the Respondent, Pro Works Contracting, Inc., its officers, agents, successors, and assigns, shall make whole discriminatees Michael Choma, Robert Whitman, and Ismael Covarrubias, by paying them the amounts following their names, plus interest accrued to the date of payment, as prescribed in *New Horizons*, 283 NLRB 1173 (1987), compounded daily as prescribed in *Kentucky River Medical Center*,

356 NLRB 6 (2010), and minus tax withholdings required by Federal and State Laws.¹
