UNOPPOSED MOTION OF THE NATIONAL LABOR RELATIONS
BOARD
FOR AN EXTENSION OF TIME TO RESPOND TO
MOTION FOR FEES AND COSTS

To the Honorable, the Judges of the United States
Court of Appeals for the Ninth Circuit:

The National Labor Relations Board (“the Board”), through the undersigned counsel, respectfully moves this Court for an extension of time to submit its response to the Application for Fees and Other Expenses Pursuant to the Equal Access to Justice Act (the Application), filed by CPS Security (USA), Inc. (CPS Security) [Dkt. 30], through and until October 31, 2018. Counsel for CPS Security has informed this

office that it does not oppose the instant motion. In support of its motion, the Board states as follows:

1. On September 17, 2018 CPS Security filed its Application. *See* Dkt. 30.
2. The Board's answer or other responsive pleading to the Application is currently due to be filed on or before September 27, 2018.
3. On September 24, 2018, the undersigned counsel requested CPS Security's position on a motion by the Board seeking an extension of time to respond to the EAJA Application, due to the travel schedules of the undersigned counsel, and to allow the parties to explore a mutual interest in discussing prospects for a potential resolution of this matter without further briefing.
4. By email later that day, counsel for CPS Security represented that it does not oppose the instant request for an extension of time until October 31, 2018 to respond to CPS Security's Application.
5. Pursuant to Federal Rule of Appellate Procedure 26(b), "[f]or good cause, the court may extend the time prescribed by these rules or by its order to perform any act, or may permit an act to be done after that time expires."

6. Based upon the good cause showing herein and lack of opposition from CPS Security, the Board respectfully requests that the Court grant it an extension of time until October 31, 2018 to respond to CPS Security's Application.

WHEREFORE, for the reasons stated above, the Board respectfully requests that the Court grant an extension of the due date of the Board's response to CPS Security's EAJA Application through and until October 31, 2018.
