

**FAST FOOD WORKERS COMMITTEE'S RESPONSE TO
THE BOARD'S NOTICE TO SHOW CAUSE**

The Charging Party, The Fast Food Workers Committee, submits this response to the Board's Notice to Show Cause as to why the allegation that the arbitration agreements unlawfully restrict employee access to the Board should not be remanded to the judge for further proceedings in light of *Boeing*, including, if necessary, the filing of statements, reopening the record, and issuance of a supplemental decision.

Inasmuch as the Board's decision in *The Boeing Co.*, 365 NLRB No. 154 (2017), had not issued when Administrative Law Judge Biblowitz issued his decision on July 6, 2016, nor when Respondent filed exceptions, the Fast Food Workers Committee wants the allegation pertaining to arbitration agreements to be remanded for further proceedings as outlined in the October 3, 2018 Notice to Show Cause issued by the Board.


