HOSPITAL'S MOTION TO POSTPONE TRIAL**

Respondent Susan B. Allen Memorial Hospital (“the Hospital”), by its undersigned attorneys, files this Motion to Request a Postponement of the Trial scheduled for June 11, 2019, and in support thereof states as follows:

1. Trial in this matter is scheduled for June 11, 2019 in El Dorado, Kansas.
2. Undersigned counsel on behalf of Defendant has a scheduling conflict, in that he has a jury trial in another case on the date of trial. That trial was scheduled prior to the Charge being filed.
3. More than 21 days remain before the scheduled hearing date. 102.16(5)
4. Accordingly, Defendant respectfully requests that the Regional Director postpone the June 11, 2019 trial.
5. This is the first postponement request made by any party and it will not prejudice the parties.
6. Respondent has provided alternative dates on which the trial could be held: July 1, 2019 and July 2, 2019.

7. Respondent has contacted Lauren Fletcher, NLRB Field Attorney, who has indicated that the other parties object to this motion.

WHEREFORE, Respondent respectfully requests that the Regional Director issue an Order postponing and rescheduling the June 11, 2019 trial for a later date, and requests such additional and further relief as this Court deems just and proper under the circumstances.
