Pursuant to the Board's Rules and Regulations, Section 102.46, Counsel for the General Counsel of the National Labor Relations Board files the following Limited Cross-Exceptions to the Decision of the Administrative Law Judge in this matter, which was issued by Administrative Law Judge Robert A. Ringler on March 4, 2019.

1. The Administrative Law Judge's proposed remedy (JD slip op. at 9, L. 23), but only insofar as it inadvertently names the incorrect employer (ADT instead of Littlejohn Electrical Solutions). No additional argument is submitted in support of this very limited cross-exception to what appears to merely be a typographical error.
