MOTION TO REMAND THE CASE TO THE REGIONAL DIRECTOR

Counsel for the General Counsel requests that the Administrative Law Judge remand this case to the Regional Director for the purpose of approving the settlement agreement entered into by the parties.

This matter was remanded to the Administrative Law Judge by the Board on January 7, 2019. On March 8, 2019, Counsel for the General Counsel moved to withdraw several allegations from the complaint, and that motion was granted by the Administrative Law Judge on March 12, 2019. On June 20, 2019, Dollar Thrifty Automotive Group (Respondent), and Communications Workers of America, Local No. 7777 (Charging Party), entered into a settlement agreement resolving the remaining allegations.

Accordingly, Counsel for the General Counsel requests that the Administrative Law Judge grant this Joint Motion to Remand the case to the Regional Director to process the settlement.
