**ORDER GRANTING THE GENERAL COUNSEL'S MOTION
TO REMAND CASE TO THE REGIONAL DIRECTOR**

On January 7, 2019, considering the holding in *The Boeing Company*, 365 NLRB No. 154 (2017), the Board remanded the above matter to the undersigned.

On March 8, 2019, Counsel for the General Counsel filed a motion to withdraw several allegations from the complaint and amended complaint. On March 12, 2019, I issued an Order granting the General's Counsel's motion to withdraw specific allegations in the consolidated complaint and set forth time frames for the remaining allegations. The parties were encouraged to engage in settlement discussions to determine whether the remaining allegations in the complaint could be resolved.

Today, June 24, 2019, Counsel for the General Counsel filed a Motion to Remand the above matter to the Regional Director for the purposes of approving a settlement agreement of the remaining consolidated complaint allegations entered into by the parties. The parties did not object to the Motion to Remand. Therefore, Counsel for the General Counsel's Motion is hereby GRANTED.
