
**GENERAL COUNSEL'S MOTION TO WITHDRAW THE COMPLAINT AND
REQUEST FOR REMAND TO REGIONAL DIRECTOR
FOR FURTHER PROCESSING**

On November 20, 2018, the National Labor Relations Board remanded this proceeding to Administrative Law Judge Paul Bogas for further processing of the complaint allegations in light of the Board's decision in *The Boeing Co.*, 365 NLRB No. 154 (2017). Following issuance of the Board's Order remanding this matter to Judge Bogas, the parties held telephonic discussions regarding the pendency of this case, the outstanding issues that needed to be addressed, and whether further litigation would ensue. Counsel for the General Counsel informed Judge Bogas and the parties that, in view of the new standards announced in *Boeing* and instructions issued by the General Counsel in Memorandum GC 18-02, the General Counsel no longer intended to pursue further litigation of this matter. Counsel for the General Counsel further informed the parties that the General Counsel would seek withdrawal of the complaint.

In view of the foregoing, the undersigned respectfully seeks withdrawal of the instant complaint. Accordingly, Counsel for the General Counsel requests that Judge Bogus remand this matter to the Regional Director so that withdrawal of the complaint can be accomplished.
