**JOINT MOTION TO REMAND CASE
TO THE REGIONAL DIRECTOR TO PROCESS WITHDRAWAL REQUEST**

Pursuant to Section 102.47 of the National Labor Relations Board's Rules and Regulations, Counsel for the General Counsel ("General Counsel"), Bartle Bogle Hegarty, Inc. ("Respondent"), and Screen Actors Guild-American Federation of Television and Radio Artists ("Charging Party") jointly and respectfully move that the Board remand the above-captioned case to the Regional Director to process the Charging Party's withdrawal request, made pursuant to a non-Board settlement between Respondent and the Charging Party. In support of this motion, the parties jointly state:

1. On August 31, 2018, the Regional Director of Region 2 issued Complaint alleging that Respondent violated Section 8(a)(5) and (1) of the National Labor Relations Act (herein the Act) by withdrawing recognition from the Union as the bargaining representative of its unit employees. On January 18, 2019, the Regional Director amended the Complaint and Notice of Hearing to add a remedial paragraph.

2. A hearing before Administrative Law Judge Kenneth W. Chu was held on February 6, 2019. Judge Chu admitted the joint exhibits into the record and closed the record on March 12, 2019.
3. On May 15, 2019, Judge Chu issued a decision and recommendation in the above-captioned matter [JD(NY)-08-19].
4. On June 5, 2019, the Board granted an extension of time to file Exceptions and Supporting Briefs until July 10, 2019. On July 3, 2019, the Board granted an extension of time to file Exceptions and Supporting Briefs until July 31, 2019. To date, no party has yet filed Exceptions and Supporting Briefs in this matter.
5. On July 19, 2019, Respondent and the Charging Party entered into a non-Board settlement agreement that resolves the matters underlying this case. As part of the non-Board settlement agreement, the Charging Party requests that the above-captioned charges be withdrawn.

Based on the foregoing, the parties jointly move and respectfully request that the Board remand the above-captioned case to the Regional Director for Region 2 for further processing of the Charging Party's withdrawal request, on the basis of the non-Board settlement reached by Respondent and the Charging Party.


