**JOINT MOTION TO CORRECT THE OFFICIAL HEARING RECORD AND
REQUEST FOR A ONE-WEEK EXTENSION OF TIME TO FILE BRIEFS**

Pursuant to Section 102.24 of the Rules and Regulations of the National Labor Relations Board, and for the following reasons, counsel for the General Counsel (CGC), District Hospital Partners, L.P. d/b/a The George Washington University Hospital, a limited partnership, and UHS of D.C., Inc., general partner (Employer), and 1199 Service Employees International Union, United Healthcare Workers East, MD/DC Region a/w Service Employees International Union (Union), hereby JOINTLY move to correct the official hearing record in the above-referenced matter, and further request a one-week extension of the briefing deadline for the parties' briefs in this matter to be due by close of business on August 16, 2019.

That the hearing transcript for day three of the hearing record, which took place on June 20, 2019, and was affirmed by court reporter Bradley Weirich on July 1, 2019, should be REPLACED with the transcribed record affirmed and certified by court reporter Kathryn Mirfin on July 24, 2019 as the true and correct copy of the proceedings that occurred in this matter on June 20, 2019.

4. That all exhibits entered by the parties into the hearing record should remain the same as the official record.

The parties further request, that in order to verify the new citations in the briefs, that one additional week be granted to the parties in the briefing, making the parties briefs due on August 16, 2019, instead of the original date of August 9, 2019.
