AMENDED ORDER APPOINTING SETTLEMENT JUDGE

Pursuant to a request from all parties in the case referenced above set to begin hearing on August 20, 2019 at 9 a.m. in Oakland, California, the Associate Chief Administrative Law Judge in San Francisco, as part of the trial assignment process, has determined that it is desirable to appoint a settlement judge in this case.

Now, therefore, Administrative Law Judge Ariel L. Sotolongo is hereby appointed as Settlement Judge in this case and has the duties and powers set forth in the Board's Rules and Regulations Section 102.35(b) respecting settlement judges.

Judge Sotolongo will conduct settlement negotiations in the case referenced above, for a term starting today, **Thursday, August 8, 2019 through Wednesday, August 14, 2019**, unless further indicated. **Judge Sotolongo will meet and confer with the parties in a settlement conference on Wednesday, August 14, 2019, at 10 a.m. in the NLRB Regional Offices, 1301 Clay Street Suite 300 North, Oakland, CA 94612-5224.** All party attorneys and party representatives with authority to settle this matter shall attend the settlement conference.¹

¹ Under Board Rule 102.35(b) no settlement judge shall undertake settlement efforts in a case absent the agreement of all parties to the use of this procedure.
