The use of "id" is not permitted when citing to the record on appeal. (See 5TH CIR. R. 28.2.2) (The record citations are not in proper format. (Remove the brackets before and after on page 2 - ROA.617, ROA.513; on page 9 - ROA.617, ROA.513, ROA.218, ROA.218, 732, ROA.601-02, ROA.120, ROA.218, ROA.447, ROA.617, ROA.512-13; on page 13 - ROA.1526-54; on page 20 - ROA.605, ROA.464, ROA.159, 328-29, ROA.121, 510-11, ROA.308-09)

The use of "id" is not permitted when citing to the record on appeal. (id on page 9 - id at 722, id on page 18 - id at 1004, id on page 21 - id at 356, id on page 22 - id at 356-59)

Note: Once you have prepared your sufficient brief, you must electronically file your 'Proposed Sufficient Brief' by selecting

from the Briefs category the event, Proposed Sufficient Brief, via the electronic filing system. Please do not send paper copies of the brief until requested to do so by the clerk's office. The brief is not sufficient until final review by the clerk's office. If the brief is in compliance, paper copies will be requested and you will receive a notice of docket activity advising you that the sufficient brief filing has been accepted and no further corrections are necessary. The certificate of service/proof of service on your proposed sufficient brief **MUST** be dated on the actual date that service is being made. Also, if your brief is sealed, this event automatically seals/restricts any attached documents, therefore you may still use this event to submit a sufficient brief.
