**GENERAL COUNSEL'S MOTION TO WITHDRAW
MOTION FOR DEFAULT JUDGMENT**

The General Counsel, based on the facts set below moves, pursuant to Section 102.24 of the National Labor Relations Board's Rules and Regulations (the Board's Rules), that the National Labor Relations Board (the Board) issue an Order granting the withdrawal of the General Counsel's Motion for Default Judgment and remanding the above-captioned case to Region 13 so that the motion may be refiled and notice properly served upon the Respondent Qawasmi Trading Inc. d/b/a Green Way Glass & Mirror & Woodworking d/b/a Temp Tech Glass (Qawasmi Trading), and grant such other, further relief as may be proper in the circumstances.

In support of this Motion, the General Counsel shows and alleges that:

1. On May 3, 2019, the General Counsel moved for Default Judgment on the grounds that the Respondent failed to comply with the terms of the bilateral informal settlement agreement approved by the Regional Director for Region 13.

2. On May 9, 2019, the Board issued an Order Transferring Proceeding to the Board and Notice to Show Cause in the above-captioned case, setting May 23, 2019 as the date any response was due. To date, no Respondent has filed a response to the Notice to Show Cause.

3. On May 10, 2019, service of process containing the Board's Order Transferring Proceeding to the Board and Notice to Show Cause was sent via USPS Certified Mail to Respondent Qawasmi Trading c/o Muin Abusharara at 1004 South 76th Avenue, Bridgeview, IL 60455.

4. On May 10, 2019, service of process containing the Board's Order Transferring Proceeding to the Board and Notice to Show Cause was sent via USPS Certified Mail to Respondent Qawasmi Trading c/o Jamal Qawasmi at 1004 South 76th Avenue, Bridgeview, IL 60455.

5. On June 25, 2019, all USPS Certified Mail sent to Respondent Qawasmi Trading at the 1004 South 76 Avenue, Bridgeview, IL 60455 address was returned unopened. The United States Postal Service designated this as an incorrect address for Muin Abusharara and Jamal Qawasmi, the individuals associated with Respondent Qawasmi Trading. Thus, the General Counsel has determined that there was not valid service on Qawasmi Trading as required by Section 102.4 of the Board's Rules.

6. In view of the foregoing, the General Counsel respectfully moves that the Board grant its Motion to Withdraw Motion for Default Judgment and remand the above captioned case

back to the General Counsel in Region 13, so that the motion may be refiled and Respondent Qawasmi Trading may be served proper notice at its correct address.
