Dear Executive Secretary Rothschild:

I am writing to inform the Board regarding a lawsuit concerning delinquent trust fund contributions filed on November 16, 2016 by the Hawaii Annuity Trust Fund for Operating Engineers (Trust Fund) against Respondent Kauai Veterans Express Co. (KVE) in case 16-00615 in the United States District Court for the District of Hawaii (Court). The Trust Fund filed a Motion for Summary Judgment on October 10, 2018 (Motion), which the Court granted on March 12, 2019. In its Order granting the Motion, the Court interpreted the parties' collective bargaining agreement to cover certain job classifications including freight truck drivers and mechanic helpers. The Court took judicial notice of the National Labor Relations Board proceedings in case 20-CA-193339, et al., to the extent necessary to resolve the Motion and administratively closed the case on October 11, 2019.

The Court's Order potentially relates to KVE's Exceptions 3 and 4 which concern the Administrative Law Judge's findings regarding the bargaining unit description and the number of truck drivers employed.
