**CHARGING PARTY REQUEST FOR EXTENSION TO FILE EXCEPTION, FILE ADDITIONAL  
EVIDENCE/ AND REQUEST APPEAL**

**Charging Party, Danilla Elmore The Ohio Bell Telephone Company (“Charging Party”), and pursuant to §102.24(a) of the Rules and Regulations of the National Labor Relations Board, Series 8, as amended. Note particularly the limitations on length of briefs with the requirements of the Board’s Rules and Regulations Section 102.114(a) & (i). pursuant to Section 102.45 of the National Labor Relations Board’s Rules and Regulations**

**Respectfully requests that an Extension to file Exceptions to the Decision of the Administrative Law Judge in this proceeding, that needs to be received by the Board’s Office of the Executive Secretary, 1015 Half Street SE, Washington, DC 20570, on or before January 24, 2020 deadline be extended for the reasons set forth herein.**

**Charging Party I Danilla Elmore respectfully request a 30 day extension to file Exception to Decision of the Administrative Law Judge and respectfully request consideration of accommodations under EEOC Regulations, 29 CFR, 1614.203.**

**For these reasons below Charging Party respectfully requests that the Division of Judges grant this request and allow additional 30 day extension to file:**

**I am in need of additional time to File Exception, File Request for New Evidence to be accepted, and or File Appeal. I never received a hard copy of the Administrative Law Judge Decision, I was only able to pull up partial info on January 2, 2020, NLRB website, and did not receive information from General Counsel Jonathan Duffey til he return to office after the holidays on Mr. January 6, 2020. In addition on January 16, 2019 I was able to review only partial Court Transcripts and in process of trying to request all Court Transcripts and Exhibits for NAACP, and Ohio Disabilities Rights Agency to review not**

just partial but all of the Legal Discripieces and error that have been discovered so far in the Court Transcripts received.

On January 6, 2020, at 8:25am General Counsel Mr. Jonathan Duffey ex[plained to me he just got notice as well, and that today January 6, 2020, Case was being Transferred to Board for next steps, and that he states he was meeting with Board with his Supervisor Mr. Taylor.

At 1:44pm January 6,2020 I received another brief call from General Counsel and was told No consideration of exception, that Board Administrators state that due to Judge decision it was based on credibility, that it was not something they can spend money on when they feel it would not be in their favor. I asked why all evidence was not produced and was told no further evidence could be submitted and my only option, and per his Supervisor only I can request an Exception, and he will call back with info on Board Exception request.

On January 10, 2020, I spoke with Regional Attorney Mr. Eric Oliver who explained to me in detail the Decision of the Administrative Law Judge, and January 6, 2020 Board Meeting it was denied and confirmed that I had a right to be in Trial Court, and that I can file an exception regarding numerous errors in Court Transcript, and prejudicial concerns etc. I did explain that I needed help, for I am not an attorney, and due to my Medical Disorder I needed help. Mr. Eric Oliver informed me that I can reach out to Bar Association, and Free Legal Assistance Agency to get help. I did that immediately that day, not realizing that the Agency involved require more time to assist me, and currently one of the Administrators of the Agency, is unexpectedly in the hospital, and Agency computer technical difficulties has caused some documents needed to not all be received, and today January 21, 2020 they just got the rest of the documentation.

I am currently in the process of assistance with NACCP Agency and with Disabilities Rights Ohio Agency, and because of my Medical Disorder it is not just a selfless need but a required need to continue to get help from these Agency , and I respectfully ask for more time to submit exceptions to the Board's Office of the Executive Secretary today January 21, 2020. After speaking with Roxanne L. Rothschild, Executive Secretary Assistance Today January 21, 2020 at 2:46 pm with her assistance she has walked me thru the process of the Extension and completed E-File, and I respectfully ask for additional 30 days to file Exception.
