1. The following information was confirmed by Thomas J. Posey of the Chicago office of Reed Smith in a telephone conference with the undersigned, on February 5, 2020.
2. Mr. Posey has represented the Respondent in recently conducted negotiations for a collective bargaining agreement with the charging-party union, UNITE-HERE Local 1.
3. Mr. Posey has informed the undersigned that the charging-party union, in the course of those negotiations, agreed to withdraw the charge and permit the dismissal of this case.
4. The undersigned is unaware if any pleadings to confirm this have been filed, but has received clear affirmation from Mr. Posey that such an agreement was in fact reached, and that the charging-party union has contractually bound itself to withdraw the charge and dismiss this case.
