**ORDER GRANTING JOINT MOTION TO MODIFY ALJ'S ORDER  
APPROVING SETTLEMENT**

On April 13, 2020, the parties in this case filed a Joint Motion to Modify to the Administrative Law Judge's (ALJ's) Order Approving Settlement, issued on March 19, 2020. In the joint motion, the parties point out that, with the exception of the Fallbrook notice, the approved notices to employees inadvertently state that such notices are "Posted by Order of the National Labor Relations Board." The parties move to replace this with language in the notices stating they are "Posted Pursuant to a Settlement Agreement Approved by an Administrative Law Judge of the National Labor Relations Board."

In addition, the parties move to correct footnotes 1 and 2 in the March 19 Order Approving Settlements. Specifically, in footnote 1 of the Order, I erroneously referred to the collective cases, which are mirrored in footnote 1 of this Order, as "CHS 2" but the correct reference should be, as counsel points out, to "CHS 1." In footnote 2 of that same order, I erroneously referred to the CHS 2 cases as "Cases 08-CA-117890 et. al.", but the correct reference is to "Cases 08-CA-167313 et. al."


