**PETITIONER’S UNOPPOSED MOTION TO
EXTEND THE TIME TO FILE ITS BRIEF**

Pursuant to Federal Rule of Appellate Procedure 26 and D.C. Circuit Rule 28(e), Petitioner Alle Processing Corp. d/b/a Meal Mart (“Alle”), respectfully submits this Unopposed Motion for a thirty (30) day extension of time for Alle to file its brief, and to otherwise amend the briefing schedule set out in the Court’s Order dated June 30, 2020 (Document No. 1849608) (the “Scheduling Order”). Respondent National Labor Relations Board does not oppose this request.

The extension of time is necessary due to scheduling issues which have resulted from the impact of the COVID-19 pandemic. Specifically, one of the partners in my practice group in the firm passed away due to COVID-19, leaving the practice group short staffed. Accordingly, the extra thirty (30) days is necessary to ensure that we have an adequate amount of time to balance the need to respond

vigorously on behalf of Alle with the pending deadlines in new matters for which we have been forced to assume responsibility.

If this request is granted, the Scheduling Order should be amended as follows:

Final Briefs	November 20, 2020

For the foregoing reasons, Alle respectfully requests that the Court extend its time to file a brief and otherwise amend the Scheduling Order as set forth above.
