**AMENDED REQUEST FOR EXTENSION OF TIME TO FILE REQUEST FOR
REVIEW**

Phoenix New Times, LLC (the “Employer”), by counsel, pursuant to NLRB Rules and Regulations §§ 102.2 and 102.67(i)(3), files this Amended Request for Extension of Time to File its Request for Review up and until September 3, 2020, and in support thereof, states as follows:

1. The Certification of Representative in this matter issued on July 21, 2020.
2. The undersigned counsel for the Employer were preparing for and were co-counsel at a substantially complicated NLRB Hearing for consolidated Case Nos. 07-CB-226531 and 07-CA-234085 from July 27 through July 31, 2020.
3. Given Counsel’s timing commitments for the trial, and related business commitments of the Employer, Counsel and the Employer were not able to sufficiently confer in advance of the conclusion of trial, and thus were unable to determine whether to seek review until within 3 days of the deadline for filing, an extraordinary and unforeseeable circumstance precipitated by the timing of the Certification of Representation.
4. Accordingly, the undersigned need additional time to prepare the Employer’s request for review.

5. Employer makes this request in good faith and not for any improper purpose, and this extension will not interfere with any scheduled hearings or other deadlines in this matter.
6. Employer has asked the Union whether they consent or oppose the extension, and the Union opposes it.

WHEREFORE, Employer respectfully requests an extension of time to file its Request for Review up to and including September 3, 2020.
